Setting up his new invention on the sand track, Eddie starts with 25 pounds of weight on the sled. He puts on the harness, and tries sprinting for about 100 yards. At the end of the 100 yards, Eddie knows, beyond a shadow of a doubt, that he is on to something. After taking a short break, Eddie sprints back to the starting line. Raising the weight to 50 pounds, Eddie sprints for another 100 yards. After another break, Eddie sprints back to the starting point. When he arrives home, he adds additional steel cross members on the bottom of the sled to increase the drag in the sand. Eddie reasons that, if he can increase the drag of the sled, he can use less weight. Once he has the design

perfected, he'll take it down to Angelo's Service Station and have Angelo weld it together. Over the next few weeks, Eddie will perfect his training sled, thereby perfecting his training.
